GRANFONDO CAMPAGNOLO ROMA 2019

(applicable only to participants not resident in Italy)

Date: October 13, 2019

Start and finish: ROME

Start area: Via dei Fori Imperiali; opens at 6:30 a.m.

Start time: 7:15 a.m.

Start groups:

Romolo (VIP) group: 1–100 Organization guests and VIPs

Numa Pompilio group: 101–300 Re di Roma

Tullio Ostilio (Charity) group: 301–500 Charity program participants

Anco Marzio group: 501–2,000 Riders in order of registration

Tarquinio Prisco group: 2,00 –7,000 Riders in order of registration, following those in the previous group

Servio Tullio group: 7,001 and above Participants in the noncompetitive Mediofondo and e-bike riders

Tarquinio il Superbo Participants in the historical ride and Roma2Bike

There are no performance-based start groups for the Granfondo Campagnolo Roma 2019.

Positions in the start grid are based solely on the date and time of receipt of registration.

Participants who start in a group in front of the one to which they are assigned will be disqualified and will not be allowed to participate in the 2020 edition.

Any rider who has not entered the start grid 15 minutes prior to the start will automatically be placed in the last group.

Riders who are not registered may not enter the race course, under penalty of immediate expulsion, and will be reported as required by law.

1. Participation

The event is open to any adult rider (19 and over) with a UCI cycling license or a medical certification of fitness for participation in competitive cycling events (the health certificate is downloadable from the registration page of the event website), and upon presentation of the ethical declaration in English.

Professional, elite (men and women) and Under-23 riders are permitted to ride only in a promotional capacity and at the invitation of the organizing committee, and may not participate in any way in the classification.

Participation in the event is by invitation, and the organizing committee may at any time and at its sole discretion decide whether to accept or reject a rider's participation.



2. Participation of ex-athletes

Participation by former athletes is allowed under the following conditions:

- Athletes racing professionally for > 2 years: 4 years after the last year in which they participated in a race open to professionals
- Athletes racing professionally for < 2 years: 2 years after the last year in which they participated in a race open to professionals
- Elite M (without contract) who have earned more than 20 points in the category: 2 years after their last license in the category
- Elite M (without contract) who have not earned more than 20 points in the category: 1 year after their last license in the category
- Under-23 riders who have earned more than 20 points in the category: 1 year after their last license in the category
- Under-23 riders who have not earned more than 20 points in the category: can obtain an amateur license at the end of the season

3. Athletes without the ethical requirement

Athletes who do not fulfill the ethical requirement and do not sign the “ethical declaration” (i.e., the declaration that they are not subject to a ban of more than six months for doping-related reasons) cannot participate.

4. Participation with e-bikes

E-bikes are allowed, but e-bike riders will not appear in the race classification and they must start in the Servio Tullio start group.

E-bikes are bicycles with a motor and a battery. Accepted types are those defined by law as bicycles and not mopeds, or those with 250-watt motors and batteries that can be from 300 kwh to 400 kwh (whose only difference is battery life). No e-bikes motors of more than 250 watts are permitted (per Directive 2002/24/EC). A rider may charge the battery or replace it.

Those who wish to participate using an e-bike may not be included in any classifications or alter in any way the outcome of the race. Use of a chip will allow hill-climb times to be recorded and reported in a special section of the general classification.

5. Registration fee

- €75.00 per participant
- €60.00 for those who preregister

Registration closes October 8.

The registration fee includes the race packet and race number, mechanical assistance (not including spare parts), medical assistance during the race, feed zones along the route, a pasta party at the finish, a commemorative medal for finishers, showers, information on results, a diploma that can be downloaded from the [Granfondo Campagnolo Roma](#) website, and a cycling jersey to be worn during the event (this is obligatory; anyone who does not wear the jersey will not be allowed to participate in the 2020 edition).

6. Preregistration

Those who preregistered at the Village or online pay the discounted preregistration fee of €60 and can start closer to the front.

7. Registration and medical certificate

Registration, whether individual or group, takes place exclusively online, through the [Granfondo Campagnolo Roma](#) website.

Any fees associated with online payment are the responsibility of the participant.

The registration form must be completed in full.

Every rider must have a medical certification of fitness for participation in competitive cycling events. The certification must not expire before the date of the event.



The medical certificate required by the rules must be validated via the DATAHEALTH service.

8. Registration confirmation and race number pickup

Every participant will receive via email (an email address must be provided at registration) a voucher with the assigned race number by October 7, 2019. If this email does not arrive, participants can check the assignment of their race numbers on the Granfondo Campagnolo Roma website beginning on October 9.

Race packets and race numbers can be picked up only upon presentation of a license or medical certification. Third parties picking up race packets must present a signed authorization and a copy of the delegator's ID.

Distribution will take place exclusively at the event Village at the following times:

- Friday, October 11, 2019, from noon to 7:00 p.m.
- Saturday, October 12, 2019, from 10:00 a.m. to 7:00 p.m.

Race packets cannot be picked up Sunday, October 13, before the granfondo.

9. Substitutions and cancellation of participation

A registered participant may be substituted by another rider from the same team after sending a request via email to iscrizioni@granfondoroma.com.

This operation will require an administrative fee of €10. The deadline for substitutions is September 15, 2019.

Any extension to the substitution deadline will be published on the event website.

If a rider is unable to participate in the event, the registration fee will not be refunded.

Riders who are unable to participate should send an email to iscrizioni@granfondoroma.com before midnight on September 15, 2019, and the registration fee (€75.00) will be held valid for 2020. Registration for the 2020 edition will not be considered valid until the participant who is withdrawing sends an email to iscrizioni@granfondoroma.com to make the request.

The registration is valid only for the year following the withdrawal and is not transferable to another rider. In the event of an increase in the registration fee, the rider must pay the difference.

10. Custom race number

The race number of any rider who registers by August 31, 2019, will be customized with his or her name.

11. Registration closes

The maximum number of participants is agreed annually with the Prefecture and the Council of the Mayor of Rome. Registration closes definitively on October 8, 2019, unless the maximum number of participants has already been reached. The organization may at any time close ordinary entries in favor of solidarity programs or similar initiatives.

12. Event cancellation

If the event cannot take place due to force majeure or any cause beyond the control of the organizing committee or the broader event organization, the registration fee will not be refunded.

13. Route

The granfondo follows a single route, the details of which are provided on the event website.

14. Cutoff and maximum time

The cutoff time to reach the intersection of the "Panoramica" climb of Lago di Albano with Via dei Laghi: 9:30. Anyone who arrives later will be required to divert to the route of the noncompetitive Mediodfondo ride.

Maximum time: 6 hours and 30 minutes.

15. Checkpoints



Crossing the the automated checkpoints, both at the start and along the route, is obligatory. Those who do not pass all the controls will not appear in the finish classification or the hill-climb rankings.

16. Characteristics of the Granfondo Campagnolo Roma

The Granfondo Campagnolo Roma is a mass participation event for competitive and touring cyclists.

17. Rights and responsibilities of the participants

- Respect all traffic laws.
- Use a standards-compliant hard-shell helmet and keep it fastened for the entire duration of the race.
- Attach the race numbers to the handlebars and to the back of the jersey, ensuring that both are clearly visible. The numbers supplied by the organizer may not be modified, reduced in size or altered in any way, under penalty of disqualification.
- Wear the Granfondo Campagnolo Roma 2019 race jersey included in the race packet.
- Carry a flat-repair kit.
- Wear clothing that is appropriate for the weather conditions.

Riders who are passed by the “fine gara” (“end of race”) vehicle must continue with the awareness that they will have no protection (mechanical assistance, road closures, corner marshals, etc.), as the road they will be following will be open to traffic.

18. Disqualification

Participating with another rider’s race number, giving a race number to another rider, starting in a start group in front of the one assigned or other serious misconduct observed by the organizers will result in immediate expulsion from the event or elimination from the classification and exclusion from the event for one to five years. In the most serious cases, lifetime disqualification can result. These measures will be adopted by the organizers.

Riders who throw objects of any kind outside the designated areas will be disqualified and will not be able to participate the following year.

A sanction by the membership organization to which a participant belongs can result in removal from the start list at any time, at the sole discretion of the organizer.

The organizer reserves the right to take action in the event of unsportsmanlike behavior that could lead to falsification of the race results.

It is absolutely forbidden, on penalty of disqualification or expulsion from the race, to use a bicycle equipped with any type of electric or electronic support or assistance, except for participants registered in the e-bike category.

19. Techological fraud

With reference to the UCI and FCI regulations, paragraph 1.3.010 and 12.1.013 regarding “technological fraud,” the race jury, with the technical support of the organizers, is authorized to carry out random or systematic checks on the participants. If the participants are not in compliance with the controls or refuse to undergo the required technical checks, they will be immediately disqualified and the competent bodies notified.

20. Timing

Timing service will be provided by MySDAM, the official timer.

21. Classifications

The timing of the granfondo will be recorded by chip, in order to create the final overall classification and that of the total time spent on the four hill climbs; times will be provided as well as rankings overall and by category. The final classification will be based on the finish times.

The classifications will be accessible on the website of the event, and each participant will be able to download his or her personalized diploma.



22. Prizes for individuals and teams / sestertius for finishers

Prizes will be awarded to:

- the first three (3) men and women in each category, based on the total time required for the hill climbs, and
- the first three (3) teams with the largest number of participants.

Everyone who completes the route will receive the commemorative sestertius after crossing the finish line.

The teams with the most participants who finish within six hours of the start will participate in the team prizes.

The club rankings will be based on the total number of members (minimum 15) participating and finishing within the time limit.

Any other prizes will be announced on the event website.

The official award ceremony will begin at 2:00 p.m. in the Village. Prizes will only be given to those who are present.

23. Categories

The categories are as follows:

- Men:
Elite Sport, 19–29 years; Master 1, 30–34 years; Master 2, 35–39 years; Master 3, 40–44 years; Master 4, 45–49 years; Master 5, 50–54 years; Master 6, 55–59 years; Master 7, 60–64 years; Master 8, 65–75 years and above
- Women:
Elite Women Sport, 19–29 years; Master Women 1, 30–39 years; Master Women 2, 40–49 years; Master Women 3, 50 years and above

24. Medical assistance

The medical assistance service includes ambulances manned by doctors and medical staff inside the Village.

25. Mechanical assistance

Cars and motorcycles following the riders and at various service points along the route.

26. Private assistance

Any type of assistance provided by private follow vehicles is strictly forbidden and will result in the disqualification of the rider receiving assistance.

Participants are advised that, to ensure a safe event, information regarding any vehicles that follow competitors illegally and enter the area closed to normal traffic, i.e., in the space between the start and the end of the race, will be recorded by the organization's inspectors and delivered to the jury and to the appropriate police, to pursue any appropriate sports- or liability-related measures.

27. Radio assistance

Along the route and at the finish.

28. Sanctions

In the event of a positive doping control at the Granfondo Campagnolo Roma, or positivity established afterward, at other sporting events, the competitor is obliged to pay the organizers, by way of compensation for the serious damage done to the image of the event, the sum of €50,000.

If the competitor belongs to a team or club, it will be jointly obliged to pay this penalty.

Any penalties collected by the organizers will be entirely devoted to youth cycling activities.

29. Complaints



Any complaints must be submitted to the jury according to the terms specified by the FCI and accompanied by the prescribed fee.

30. Changes

The organization reserves the right, at its sole discretion, to modify these rules. The www.granfondoroma.com website is the official vehicle for the transmission of information regarding the event, and therefore all official communications will be posted there.

32. Applicable rules and indemnity

All participants in the race must strictly comply with the rules of the road, taking utmost care and considering the inherent dangers of cycling.

For matters not addressed in these rules, the rules of the FCI apply.

The organization accepts no responsibility for accidents or damage to persons, animals or things that could take place before, during or after the cycling event (including, for example, but not limited to, damage due to unfavorable weather conditions, rough road surfaces or insufficient lighting).

For this reason, participants who do not already have an accident insurance policy are strongly advised to activate one or purchase and activate the UNI-POL/SAI accident insurance policy directly through the registration form.

By registering for the race, the participant expressly accepts all the provisions of these rules and undertakes to indemnify and hold the organizers harmless from any liability and from any claim and/or request for compensation for damages to persons and/or things that could result in accidents, of any kind or nature, that may occur before, during or after the race.

Race participants shall also not (a) leave their bikes and personal belongings unattended or (b) park other vehicles (e.g., cars, motorcycles) inside the Village. It is understood that in the event of theft or damage to a rider's bicycle, personal property or other means of transport, left unattended and/or parked either inside or outside the Village, no liability can be attributed to the organizers, or any request or claim advanced against them.

In the event that the organization should be the unsuccessful party in claims and/or demands for compensation from third parties for damage to persons and/or things deriving from what is indicated in this article 32, the participant shall compensate the organization.

33. Signature and authorization of handling of personal information

By submitting the online registration form, the competitor — or, in case of a minor, the parent representing him or her — declares that he or she is in possession of a medical certificate in accordance with D.M. of 18/02/1982 and of liability insurance, and has read these rules, accepting them fully and unconditionally.

With regard to the processing of personal data, the participant, by selecting the specific box at the bottom of the online registration form, declares that he or she has read the linked privacy notice pursuant to Article 13 of EU Regulation 679/2016 (**GDPR**) (**Privacy Notice**) and has been informed through the above-mentioned privacy notice that consent for the processing of data strictly necessary for participation in the race is not necessary when the processing is justified on a different legal basis. The provision of personal data is optional; however, those who do not provide this personal data will be unable to complete the registration process. For purposes other than those closely connected to participation in the race, the processing will be carried out only subject to the participant's consent, which, in any case, can be revoked at any time.

The data must be complete, current and legible, also for insurance purposes.

The data, as better explained in the privacy notice — which is an integral part of these rules and which is referred to here in its entirety — may also be transmitted and processed by third parties



offering services connected to the race, such as, for example, those involved with timing, preparing and publishing the results lists, and photographing or filming the competitors. Such entities, with regard to data processing outsourced and carried out on behalf of the data controllers (as defined in the privacy notice), will act as external data processors, pursuant to GDPR section 28. Some of these entities, however, may act as data controllers with respect to the transmitted data, subject to the release of a proper information statement pursuant to GDPR Article 14, unless otherwise provided for by law.

To this end, please also carefully review the privacy policy of our official photography partner, SPORTOGRAF GmbH & Co. KG, at www.sportograf.com/it/service/general/privacy.

With regard to the lists of results and rankings and the publication of photos, videos, audio and/or video recordings of various kinds, the data controllers may use the data and images of the athlete for internal and external purposes (various publications, sports videos, via telematic means and on the Granfondo Campagnolo Roma website).

Regarding the images and/or video recordings, the athlete may appear alone or together with other subjects during initiatives promoted by and for the organization or any other entity indicated in the privacy notice as a data controller.

By reading the privacy notice, the participant acknowledges that the aforementioned processing is strictly necessary in order to carry out the purposes explained in the privacy notice for which consent is not required, without prejudice to the rights set forth in Articles 15 et seq. of the GDPR that may be exercised at any time, as further described in the privacy notice.

The participant may also obtain further information about the processing of personal data carried out through the [Granfondo Campagnolo Roma](http://www.granfondo.com) website.

Furthermore, by submitting the online application, the competitor, together with the representative of his or her team, self-certifies that he or she is not subject to any sporting sanctions, civil and/or criminal penalties of more than six months, even if reduced, for matters relating to doping and declares that he or she has not taken — and will not take — substances included on the list of prohibited substances of the World Anti-doping Agency (WADA).

False declarations will be prosecuted according to law.
