

THE HISTORICAL CYCLE 2019

Date: October 13, 2019

Departure and Arrival Location: Rome

Start: Via dei Fori Imperiali, from 6.30

Departure Time: 7.15 - after the departure of the participants of Granfondo Campagnolo Roma

Grid: Grid Tarquinius Superbus | Participants in The historical cycle

Participants that will start in one of the previous grids, reserved for participants in Granfondo Campagnolo Roma and Mediofondo, they will be disqualified.

Cyclists not enrolled will not fit inside the path reserved for the race, under penalty of immediate expulsion and will be reported as required by law.

Participation

Open to all, even non-members, and even if not accompanied by medical certificate for cycling, however, strongly recommended in order to check if your health is adequate to carry out sporting events.

Participation fee

The historical cycle

€ 40.00

The participation fee includes: race package, dorsal, mechanical assistance (not including spare parts), health care in the race, supplies along the route, pasta party on arrival, commemorative medal, showers service, results information, Diploma that can be downloaded from the site [Granfondo Campagnolo Roma](#).

Registrations

The registrations, individual or cumulative, are carried out exclusively on-line, through the site [Granfondo Campagnolo Roma](#).

Any payment fees are charged to the participant.

The registration form must be completed in full and you will be required to report the following information: full name, mobile and e-mail address.

Registration confirmation - Withdrawal of race pack - Check cards

Each participant will receive to your e-mail address (which must necessarily be given at registration), the voucher with the number assigned to it, by 9 October. In the absence of receipt of the voucher, from October 10 you can check assignment on the site [Granfondo Campagnolo Roma](#).

The race pack can be collected only by showing an identity card, also by third parties that are required to have a specific power of attorney drawn up as PROXY model.

The distribution will take place exclusively at the Village in the following days and times:

Friday, October 11, 2019 from 12:00 a.m. to 7.00 p.m.

Saturday, October 12, 2019 from 10:00 a.m. to 7.00 p.m.

The organization will communicate through its own website, where you can also sign up to the event at the village, on 11 and 12 October 2019.

Substitutions - cancel participation

It's possible to replace a participant when he completed their registration and always within the same team membership after sending a request via e-mail at iscrizioni@granfondoroma.com.

For this operation it will be required a secretarial contribution of 10 Euros. The deadline for the replacement is 15 September 2019.

Any postponement of the date of replacement substitutions will be published on the website.

If the member is unable to attend the event, the registration fee will not be refunded.

If it will be impossible to participate, a communication via e-mail at iscrizioni@granfondoroma.com before 00:00 on September 15, 2019, the sole portion (€ 40.00) will be held valid for enrollment of 2020. The registration of the edition 2020, will not be considered valid until the subject withdrew will not send an e-mail to iscrizioni@granfondoroma.com, to request this feature.

Registration is valid only for the year following the waiver, is nominal and not transferable. In case of increase of the registration fee, it must be paid the difference.

Registration deadline

Granfondo Campagnolo Roma is an event that provides for a maximum number of participants agreed annually with the Prefecture and the Municipality of Roma Capitale. The organization may close at any time ordinary entries against solidarity programs or similar initiatives.

In the event L'Imperiale Roma the organization will communicate, through its website, where you can also register in the Village on 11 and 12 October 2019.

Event cancellation

If, for reasons of force majeure or any additional reasons not attributable to the organization, the event does not take place, the entry fee will not be refunded.

Route

La pedalata storica provides a single path, the details of which are indicated in the event website.

Maximum time

Maximum time: 6 hours and 30 minutes.

La historical cycle

The historical cycle ride, about 30 km, the details of which are indicated in the site of the event, will start immediately after the start of the Gran Fondo Campagnolo Roma and Mediofondo. It is a non-competitive event, open to everyone even if not registered or possess medical certificate for cycling.

The historical cycle is an event for vintage racing bikes or in vintage style, reserved for cyclists, vintage with bicycle clothing or historical inspiration.

For vintage bikes means all racing road bike built up to 1987 without or with gear, such as those built at the end of 1800 or early 1900. These bikes have presumably the steel frame, but rare

aluminum frames are allowed, such as those of Alan and Vitus with joints screwed and glued and Graftek Exxon frames of the late '70s with carbon tubes and lugs aluminum.

As regards the bicycles components must be in line with the following directions:

the more recently built bike with a derailleur gear type Simplex, Huret, Campagnolo, Zeus, Shimano, Suntour, etc. must have the gear levers on the down tube of the frame (in derogation are allowed bar-end controls before 1980);

the pedals must be equipped with toe-clips and straps or, for older bikes, just like the originals; It is not allowed any kind of quick release;

the passage of the wires of the brakes must be external to the handlebar (is allowed passage of the wires inside the frame);

older bikes with gear must have original spare parts such as Gear Race, Paris Roubaix, Vittoria Margherita, etc.

the wheels must be fitted with wheels with low profile (less than 20 mm) and at least 32 spokes; hare allowed aluminum wheels, steel and wood;

either tubular tires that are permitted;

It is desirable, not obligatory, that the seats are in the same period of the bicycles, so models from 1987 or earlier; alternatively we suggest new saddles, provided they are replicas of old models, such as Brooks leather saddles, reproductions of Cinelli, San Marco, etc;

It has allowed the adjustment of the free-wheeling in relation with the difficulties of the path; there are no restrictions on the type of brake, provided they are in line with the period of construction of the bicycle and provided they are working in safety way.

bikes of the early 1900s without a gear they do not need to be bound to the above list as long as equipped with original components.

You can also use bicycles in vintage style, or racing road bikes with steel frames of new or more recent production but with similar design characteristics to vintage bicycles, provided assembled with components similar to the originals, as described above.

In particular, the bikes inspired bike 70s and 80s must meet at least the first three points above (a, b, c) in respect of gear levers, toe clips and straps, wire brake.

At the request of the interested parties, it will be granted exemptions on the type of bike for handicapped participants.

It will be disqualified any rider at the start or should be surprised on the route with the bicycle not complying with this Regulation.

Rights and obligations of the participants

Please observe the Highway Code.

Use an approved helmet and keep it fastened throughout the race.

Attach clearly visible on the handlebar number (front) and back the number (dorsal), both supplied by the Organization. These numbers can not be changed, reduced or altered in any way, under penalty of disqualification.

Bring a repair kit.

Wear appropriate clothing according the weather.

The riders passed by the vehicle "after the race" will continue the ride conscious of not having any protection (mechanical assistance, closing roads, etc.) And all roads will be open to traffic.

Disqualifications

Participants wearing the number of another cyclist or given to other participant, the start in a gate previous that assigned or other grave fact which is detected by the organization, will cause the immediate disqualification from the event and the exclusion from the classification other than a disqualification from the event from one to five years. In serious cases, disqualification may be for life. The above measures decided by the organization. Competitors who throw objects of any kind outside of allowed marked spaces will be disqualified and can not participate the following year.

The organization reserves the right to take action if a notice of a non sporty conduct.

Certificate of participation

All participants can download from the site of the event the custom diploma attesting their participation.

Medical care

The medical backup service includes ambulances manned by doctors and medical staff.

Mechanical assistance

Cars and motorcycles in various service points along the way.

Private assistance

The assistance of any kind from private vehicles following the race is strictly prohibited, under penalty of disqualification of the participant.

It warns that, for a correct and safe running of the event, the data of the vehicles that were to follow abusively competitors and transit spaces closed to normal traffic, ie in the space between the beginning and the end of the race, they will be detected by the inspectors of the organization and delivered to the Jury and to the competent police to any measures of sport infringement and of the highway code

Radio assistance

On the way and on arrival.

Complaints

Any complaints must be submitted to the Jury in regular terms accompanied by the prescribed fee established by F.C.I.

Variations

The organization reserves the right at any time the right to modify at its sole discretion, changes to this Regulation. The website is the www.granfondoroma.com the official instrument of the event and therefore all official communications will be disclosed herein.

Standards

The organization accepts no responsibility for accidents or damage to persons, animals and things that will happen before, during and after the cycling event. It's mandatory for all participants to the event the respect for and observance of the rules of the Highway Code. As non in these rules, it will apply F.C.I. regulations.

Signature

By submitting the online registration form, the competitor or, in case of a minor, the parent who takes place, declares to be in possession of the medical certificate under D.M. of 18/02/1982, to be in possession of regular card, for liability insurance to third parties and to have read of this Regulation, accepting it unconditionally in every point and consent to the use of your personal data.

Having regard to the processing of personal data, the participant, by selecting to check the specific box at the bottom of the online registration form, declares to have read the information statement pursuant to art. 13 of EU Regulation 679/2016 ("**GDPR**") ("**Information Statement**") made available at the specific link and to have been informed through the above-mentioned Information Statement that consent for the processing of data strictly necessary for participation in the race is not necessary, when the processing is justified on a different legal basis of processing. The provision of personal data is optional. Lacking the communication of such personal data, you will be prevented from completing the registration. For the purposes other than those strictly necessary for the participation to the race, the processing will be carried out only subject to participant's consent, which, however, can be revoked at any time by the participant. The data must be complete, updated and legible also for insurance purposes.

The data, as better explained in the Information Statement - which is an integral part of this Rules and which is intended here integrally referred to - may be communicated and processed also by third parties offering services regarding and connected to the race, such as, for example: those aimed at timing the time, prepare and announce the lists of results and those with the purpose of photographing or filming the competitor. Such subjects/entities, having regard to those data processing outsourced and carried out on behalf of the data controllers (as defined in the Information Statement), will act as external data processor, pursuant to section 28 of GDPR. Some of these subjects, however, might act as data controllers in respect the communicated data, subject to the release of a proper information statement pursuant to Section 14 of GDPR, unless otherwise provided by laws.
